Domestic Violence

What is it? It is a pattern of verbal, physical, sexual, emotional, psychological or financial abuse, threats or coercion used by one person to exert control over another in a dating, family or household relationship.

> There is NO Excuse It is NEVER the Victim's Fault!

ABUSE can be PHYSICAL, SEXUAL, PSYCHOLOGICAL, or ECONOMICAL.¹

BATTERY is NOT a temporary loss of temper; it is a CRIME.

IT IS ESTIMATED THAT DOMESTIC VIOLENCE IMPACTS:

- 25% of ALL women.²
- 1.3 million women annually in the U.S.³
- Children at an alarming rate. More than five children die every day as a result of child abuse. And about 30% of abused and neglected children will later abuse their own children. ⁴

DOMESTIC VIOLENCE IN ASIAN IMMIGRANT COMMUNITIES:


- 41% to 60% of respondents in surveys of Asian ethic groups in the U.S. have reported experiencing domestic violence during their lifetime.^₅
- In the greater Chicagoland area, 72% of Asian immigrant survey respondents said they or someone they know experienced domestic violence.⁶
- Asian victims are 4 times less likely to seek help than Whites, Blacks, or Latinos.
 - Common barriers for immigrants in seeking help:
 - Language barriers limiting access to help;
 - Fear of deportation;
 - Fear of police and judicial system;
 - Cultural/religious issues;
 - Isolation & lack of resources; and
 - Lack of knowledge and misinformation about various systems in America.⁸

ALL PEOPLE IN THE U.S., <u>REGARDLESS OF IMMIGRATION</u> <u>STATUS</u>, ARE GUARANTEED BASIC PROTECTIONS UNDER LAW: • Right to call the police and report crime; • Right to obtain protection order; Bight to leade expection order;

- Right to legal separation or divorce;
- Right to ask for custody & financial support;
- Right to access help!
- The Violence Against Women Act (VAWA) created special routes to immigration status for certain battered immigrant victims.
- U-Visa gives victims of violent crimes temporary legal status and work eligibility in the U.S. for up to 4 years
